- All computers should be installed with valid Antivirus software. The use of pen drives, CDs etc. for file transfer is discouraged and will be entertained only under special cases
- System admin and technical assistant shall update the systems on regular basis with antivirus Software and other requirements as per need
- The institution campus is under CCTV surveillance at strategic points which includes entry and exit points of all the buildings, inside and outside of classrooms.

- Usage of mobile phones is strictly prohibited inside class rooms and in Examination Section.
