The College is a constituent institute of KLE Society, Belagavi which is a prestigious education management body. KLE Society isrendering service since 108 years to the field of education.

The institute is working in consonance with the goals and vision of the management. The institute is affiliated to Bengaluru City University, Bengaluru and is recognized by the UGC with 2f & 12b. On its march towards excellence, the college has several recognitions and awards.

The college is successfully assessed and accredited by NAAC in 3<sup>rd</sup> Cycle having A<sup>+</sup> Grade with CGPA of 3.53. The college is awarded by UGC with STRIDE component-I fund for research capacity building and human resource development. The Institutional goals and objectives are reflected in the academic programs offered by the Institution.

### OBSERVATIONS ON ACADEMIC AND ADMINISTRATION

#### Admission of students:

The Institute has a well-defined strategy and policy regarding the undergraduate and postgraduate admission process of students. It scrupulously follows rules and regulations laid down by the affiliating University, State Government and UGC, New Delhi.

The admissions are made on merit basis in a transparent mode. However, in some programmes, written test and counseling followed by interviews are conducted for admissions. The college

provides equity and access with respect to admission and the statutory norms related to the admission, curriculum design, development and delivery.

Records show that there is demand for admissions in commerce, computer applications, computer science and Tourism disciplines. Stable admissions are observed in other streams of the undergraduate and postgraduate courses. Institution maintains high standards in its admission process.

#### Curriculum:

There is a sufficient documentary evidence to show that the Institution follows curricular standards set by the affiliating University and the UGC.

The college offers both UG & PG programme in Arts, Science, Commerce and professional programmes like BCA, Business Administration and Hotel Management, few entrepreneurship programmes like Fashion & Apparel design, Tourism & Travelling and Journalism

- The college has effectively implemented NEP-20 in undergraduate programmes by following the rules and regulations laid by the State Higher Education Council, Govt. of Karnataka and parent University. To adapt the NEP, the college has organised several workshops for parents, students by inviting resource persons and experts in the beginning of the academic year. Adequate number of choice based open elective subjects across the interdisciplinary streams is offered to the students and it is observed through the official records
- Short term skill enhancing and value added courses are designed and developed by the
  departments. These courses are introducedas per feedback from stake holders. The syllabi is
  designed by the teachers of the college with ad-hoc Board of Studies (BoS) in respective
  subjects
- The college has adopted CBCS mode of education, the choice of subjects of student's interest for UG and PG courses
- Pedagogical diversity is evident in the curricular environment and design
- The faculty practice different innovative instructional methods which are appropriate to the content thought and learning, enabling the students to develop global competence
- The Institution has adopted course package to provide every student which significantly impacts the teaching learning processes and final outcome
- Students are given ample opportunities to have hands on learning and experiential learning in different occasion like field visit, classroom, industry and community awareness programme



- The information centre of the institution has a rich collection of text books, reference books, e-books, journals, e-journals, complete digitalisation with INFLIBNET connectivity and facilitated with integrated library management system (IMS) and Libinfo.
- The competent and qualified faculty as facilitators are adequate in number are putting efforts to train students in all the curricular, co-curricular and extracurricular activities
- The records are evident to prove that students are regularly presenting papers in class-room (inhouse) seminars
- Students involve with interest in curricular based projects and internship activities in professional courses
- The college has established MoU with a few industries and academic institutions for the exchange of academia and research
- FDP programmes are conducted to update faculty
- Students actively participate in the Curriculumenriched programs like extension activities
- College has taken very effective measurements to overcome COVID pandemic situation and avoided the students' academic loss. A well-defined strategy was developed to conduct the online theory and practical classes by using standard social platforms like Cisco-Webex, Zoom, Teachment, Telegram, Great learning and Google meet
- Mentor-mentee system of the college has done a commendable job in pandemic situation to connect the students and teachers. The enhanced university exam result analysis report is evidence for the above statement

#### Research:

- The commerce fraternity of the college has been recognised by the Bengaluru City University for the Ph.D. programme
- The college has established Dr.Prabhakar B. Kore, Research Centre to take up research projects
- College is awarded with UGC STRIDE component-I grant to enhance the research building capacity and human resource development. Grant is utilized under the guidance of Mentor and monitoring Committee of the UGC for the organisation of international, national level workshops, seminars, conferences, hands on training, FDP, SDP, skill enhancing short term certificate courses and minor research projects to faculty and students



- The data of the Institution pertaining to outcome of the research is moderately good which is evident by presentations at International and National level academic platforms and projects undertaken
- As a part of social responsibility, the college is in practice of celebrating national festivals, national days and other relevant community oriented activities in association with NSS, NCC, YRC, Scout and eco-club of the college
- The college encourages consultancy services of the faculty in their area of expertise

#### Infrastructure:

- The college has sufficient and well provided facilities that enhance the teaching and learning process
- There are sufficient number of classrooms, Seminar hall and Conference hall. The classrooms are enabled with ICT having Wi-Fi/ lan and ACT fibre net connectivity
- The central library is with an adequate space and fully digitalized automation which satisfy the reading culture
- The language lab and audio-visual studio is appropriately used to develop communication skills among the students
- The laboratories are well equipped with state-of-the-art equipments
- The college caters to the needs of students in physical education with adequate space and facilities. The list of University blues, inter collegiate, inter university prizes and medals are evidentiary document for their excelled achievement in sports activity
- The Institute provides hostel facility and runs a well maintained hygienic subsidised cafeteria.

- Attendance sheets for Remedial classes need to be duly signed by the students
