#### WOMEN ANTI-SEXUAL HARASSMENT CELL

The Internal committee for women Anti-sexual Harassment Cell in S. Nijalingappa College constituted according to "The Sexual Harassment at Workplace" (Prevention, Prohibition and Redressal) Act 2013, in order to address the issue of Sexual Harassment at Workplace for ensuring gender equality. The committee is established to generate awareness, review and address the complaints on sexual harassment in college campus.

#### **Objectives:**

- To uphold and enhance women's status.
- To raise public awareness of women's issues, particularly those pertaining to discrimination based on gender.
- Developing women's self-confidence and to provide guidance on Women Welfare Laws.
- To emphasize the significance of gender, racial, economic, social, and spiritual equality.
- To emphasize the significance of cleanliness, hygiene and well-being.
- To plan workshops and seminars to stop sexual harassment and enhance the overall health and happiness of female students, faculty, and staff at the College.
- To create and preserve a respectful, friendly workplace where female employees and students can work.
- To facilitate a safe environment that is free of sexual harassment and free of gender-based discrimination
- To develop guidelines and norms for policies against sexual harassment
- To organize gender sensitization awareness programme
- Creation and delivery of customized awareness training sessions to the management, internal complaints committee and employees, on a need basis

#### **Activities:**

- Organization of workshops, invited guest lectures and seminars to generate health, hygiene awareness among women.
- Encourage those who work in the field of women's development to get involved in the Cell's activities.
- To encourage women to be self-reliant, arrange different kinds of training programs and raise knowledge about self-employment opportunities.
- Initiatives to enrol the girl students in NCC, NSS, and YRC to develop self-reliance and confidence.
- Promote women empowerment by organizing health camps for blood grouping, blood donation, eye checkup, stem cell banking, screening of cervical cancer, organ donation & hair donation for cancer patients.

#### **Execution of rules and regulations:**

#### On receipt of complaint

- The committee shall, on receipt of a written complaint, promptly initiate inquiry proceedings as per the directions under the UGC and state Government directions.
- Sexual Harassment has been defined as: An act of sexual harassment includes any one or more of the unwelcome acts or behaviour, whether directly or by implication.
- Physical contact and advances; or A demand or request for sexual favours; or Making sexual coloured remarks; or Showing pornography; or Any unwelcome physical, verbal or non-verbal conduct of sexual nature.

#### Roles and responsibilities:

- The committee has to ensure enough steps are taken to create awareness on the topic.
- If in case any person approaches any of the committee members, the member is immediately required to inform others.
- A written complaint is required to be taken from the aggrieved person, necessary action to be taken, preferably to settle the matter through counselling and conciliation as soon as possible.
- In case the matter is not so sorted, inquiry to be conducted and matter to be sorted out within 10 days from the date of compliant.
- The members to be vigilant all the time and ensure that there is no such incident taking place in campus by creating awareness and having an open dialogue with all the students.

#### Following are the Guidelines to be strictly followed

- The complainant will have to submit a written and signed complaint addressed to the Presiding officer of the Cell
- The counsellor will call the complainant for a personal meeting, usually within a week from the submission of the written complaint
- The members of the Cell will discuss the complaint
- If the case falls outside the purview of the Cell, the complainant will be informed to Principal/management/Legal cell of the college and UGC
- If the case comes under the purview of the Cell, an enquiry committee will be set up. The
  Committee will submit a report and recommend the nature of action to be taken at the
  earliest by Principal
- If any legal action is required with the help of advocate member of the cell complaint is forwarded to police
